**CANCELLATION POLICY.** In the event of your cancellation, a cancellation fee of \$250.00 will be deducted from the deposit, if the cancellation is made up to 60 days prior to the pickup date. The rental payment is due at least 30 days before pickup. If a guest cancels less than 60 days or is a no show, there will be no refund of the deposit and no refunds of payments if a rental is cancelled within 30 days of pickup. Your reservation deposit is added to the \$1000 security deposit to become a total of a \$1500 security deposit during your rental period. If you reserve through GetRV they conveniently manage all payments and deposits, however they charge you credit card processing fee of 3.5%.

**VEHICLE AVAILABILITY:** The Owner has no liability for any expenses or damages associated with the non-availability of the Vehicle for reasons beyond Owner's control, such reasons to include breakdowns and late returns by a previous renter. If the RV rental is canceled by the Owner or Renter due to those reasons, then the Owner is liable for the amount of the reservation deposit and/or any fees already paid Owner. If the Rental is not canceled and pickup is delayed, then the Owner is responsible only for the amount of that delay period rental charge.

In no event, whether as a result of breach of contract, warranty, tort (including negligence), or otherwise, shall Owner be liable for any consequential, incidental, or exemplary damages, including but not limited to, loss of profit or revenue, loss of use of the products, or any associated equipment, cost of substituted vehicles, facility, living expenses, transportation, communications, professional services, down time costs, or claims of the Renter for such damages.

**INSURANCE.** The customer shall provide proof of insurance 30 days prior to the pickup date, which will cover the customer and Motorhome for the duration of the rental period. Inexpensive [daily coverage is also available from MBA Insurance](#). We are Dealer Number [301069](#) and you will select [Series 2](#) coverage on our rentals. Takes just a minute.

**DRIVER REQUIREMENTS.** The Vehicle may only be driven by a qualified driver 30 years of age or older possessing a valid driver's license. All drivers must be covered under the customer's insurance and bound by the terms and conditions of the rental agreement.

There may be other costs as agreed. You will have to return the Vehicle as per the Rental Agreement. Please tell us generally where you're going, as well as what we can do to be good hosts for your rental. We reserve the right to restrict use of the coach at NASCAR, rock concerts and other events with a history of rental vehicle damage and to charge special rental rates for them.
